WHY YOU SHOULD DO IT

This is an experimental project whose objective is the reduction of the quantity of unseparated waste material and the introduction of a more equal price, in order to help citizens to become more aware.

The test project concerns the collection of DRY WASTE:

in addition to the initial supply of ECUObags (calculated to be enough for family needs and for which the TARI figure has already been worked out), the user also pays depending on the number of extra bags used.

The project already involves an increasing number of CEM Ambiente Member Councils with ecologically significant results.

Become a more virtuous and aware citizen

You only pay depending on the “dry waste” that you produce.

The less dry waste you produce the more you safeguard the environment and the place where you live.

Improve the percentage of separated waste in your city

Increase the economic resources for your community, thanks to the savings obtained as a result of separating waste better.

ADVICE FOR GOOD PRACTICE

Reduce the volume of your unseparated waste as much as you can so as to best fill the ECUObag.

When you go shopping think about the waste you will produce

Respect the area where you live. Don't throw rubbish into public waste bins, along the road or in green spaces.

Always think about what you are throwing away: check to see if you can take it to another recycling depot.

HOW WHERE AND WHEN

What is the ECUObag?

The ECUObag is the new **semi-transparent traceable** bag which **must be used** for the collection of dry waste

What should I put in the ECUObag?

“Dry ” waste. (You can find a list on the back of the CEM AMBIENTE calendar from your town). Remember to put loose dry waste in the ECUObag without using other bags

Where are the ECUObags distributed?

At the collection points at the days and times indicated on the back of the CEM AMBIENTE calendar from your town . Collecting the ECUObags is essential

How many ECUObags am I allowed?

The number of bags depends on the number of people in your family

What do I need to collect my ECUObags?

In order to collect your bags you have to go to one of the distribution points with your CRS/CNS or CEM Card

if I need other ECUObags, where can I buy them and how much are they?

You can buy them at the city's Ecology Office using your CRS/CNS or CEM card at a cost of:

-€10 for a roll of 15 40 litre ECUObags

- €30 for a roll of 15 120 litre ECUObags

The cost of the bags will be included in the next bill. The price includes the cost of disposing of the waste material in the bag

Two examples:

Families with children under 3: already taken into account with the supply of bags

People with incontinence problems: integrated supply with self-certification

Can I use other bags for the dry waste?

No, only ECUObags will be collected

and the old grey bags?

use them for Multipak disposal

Why is there a code printed on the ECUObags?

So that if necessary it is possible to trace the owner of a particular ECUObag

Why are some ECUObags red and others blue?

RED ECUObags are for domestic users

BLUE ECUObags are for non-domestic users (companies, shops, restaurants, bars etc)

DOMESTIC COLLECTIONS



DRY – Dry waste

WHAT: items used for cosmetics and personal hygiene such as plastic razors, combs, brushes, toothbrushes, cotton buds, soap, nappies and sanitary towels, plasters; rubber items and hoses, kitchen gloves; stationery items such as rulers, erasers, pencil shavings, correction fluid, pens and markers, CD/DVDs, carbon paper; personal accessories such as belts, tights, hats, shoes, fabrics; home furnishings such as candles, vacuum cleaner bags, dirty rags, dog and cat litter, x-rays; kitchen items such as non-biodegradable coffee capsules, plastic cutlery, plastic or Teflon cutting boards, sponges, anti-mosquito tablets, elastic items in general; anything else that cannot be further separated.
HOW: collected in semitransparent bags weighing not more than 20kgs.
WHEN: to be placed outside by 06.00 on the day of collection

DO NOT insert packaging (glass, tins, paper/cardboard, plastic packaging etc.)
DO NOT use black bags or shopping bags.



MULTIPAK – plastic, metal and double-sided packaging

WHAT: plastic packaging: plastic bottles and containers for mineral water, soft drinks, edible oils, juices, milk; egg trays, fruit and vegetables meshes, films for food, various cans, Tetrapak containers, polystyrene trays, containers labelled PE-PET-PVC-PP, plastic cups and plates (no food scraps), blisters; aluminum or steel packaging; cans for soft drinks and beverages in general, aerosol spray cans for perfumes, hair spray and cream; tins of tuna, tubes for creams, yogurt lids, aluminum foil, plastic and silicone tops, plastic and metal clothes hangers etc.
WHEN: to be placed outside by 06.00 on the day of collection
HOW: collected in semi-transparent bags.

DO NOT insert materials other than those indicated, paper and cardboard, paint and solvent containers (labelled t/f), large scale amounts of polystyrene and cellophane.



ORGANIC – Organic waste

WHAT: left-overs of raw and cooked food, rotten food, fruit peel and skins, coffee grounds and tea bags, egg shells, cut flowers and plants in small quantities, corks, wooden ice lolly sticks.
HOW: collected in buckets or wheelie bins. Only use bags made from bio-degradable material.
WHEN: to be placed outside by 06.00 on collection day

DO NOT insert non bio-degradable materials (nappies, plastic bags, aluminium foil/sheets, plastic packaging etc.)
DO NOT use plastic bags.



PAPER – paper and cardboard

WHAT: newspapers, magazines, advertisements, sheets of paper and notebooks, paper bags for bread and fruit, books, tickets, pizza boxes (with no food inside), paper napkins, small crushed paper packages, packaging pieces in card or cardboard.
WHEN: to be placed outside by 06.00 on the day of collection
HOW: collected in paper bags, cardboard boxes and tied parcels weighing not more than 20kgs or in a bin (if provided by the Council).

DO NOT insert greasy, oily or dirty paper and do not use plastic bags.



GLASS- glass containers

WHAT: glass bottles of any colour (also with cork/top), glass jars (with top or lid). Bottles and jars must be completely empty; do not dispose of oils in sinks.
WHEN: to be placed outside by 06.00 on the day of collection
HOW: collected in containers or wheelie bins.

DO NOT insert plastic bags or containers, shards of ceramics, porcelain or terracotta (cups, plates, vases), neon tubes, light bulbs, glasses and other glass objects.

OTHER HOME COLLECTIONS



GREEN – garden waste

WHAT: grass cuttings and leaves, small branches.
WHEN: to be placed outside by 06.00 on the day of collection
HOW: collected in containers weighing not more than 20kgs or wheelie bins.

DISPOSAL OF WASTE MATERIAL AT THE RECYCLING DEPOT

MEANS OF ACCESS for domestic users:

All domestic users can access the Community Recycling Depot for the disposal of domestic urban waste products from places and spaces used for domestic residences located within the municipality.

Access to the Depot is controlled by an electronic computerized system and consequent use of a CRS (Regional Services Card) or CNS (National Services Card).

MATERIALS THAT CAN BE DEPOSITED AT THE DEPOT:

a) **WOOD:** durable goods such as furniture, doors and windows; packaging such as pallets and packing boxes or pieces thereof.

Furniture should be broken down into different materials (mirrors, glass, metals, plastics) before being disposed of.

Particularly bulky pieces of furniture must be dismantled or broken down.

b) **IRON AND METAL SCRAP:** bed bases, metal fences, clothes dryers, pots and pans, metal shelves, bicycles.

Do not dispose of mopeds, engine oil filters, metal working scrap such as shavings, swarf and dust, metal containers contaminated with dangerous substances.

Do not dispose of electrical or electronic devices.

c) **PAPER AND CARDBOARD:** newspapers, magazines, advertisements, sheets of paper and notebooks, paper bags for bread and fruit, books, cards, pizza boxes (with no food waste inside), paper towels, small cardboard packaging reduced in size, pieces of card or cardboard packaging.

Do not dispose of products with lined paper (e.g. upholstery, laminated paper), dirty or greasy paper.

d) **PLATE/ROUND GLASS:** window panes, mirrors, fish tanks, demijohns, glasses and other crystal glass objects.

Before disposing, separate the items into their component parts (frames, profiles, demijohn straw casings, inserts and electrical items found in fish tanks).

e) **GLASS CONTAINERS:** glass bottles of any colour (also with cork or stopper), glass jars (also with lids or tops).

Before disposing, empty bottles and vases completely.

f) **HARD PLASTICS:** crates, jerry cans, buckets, vases, tubes and pipes, garden furniture, toys.

Do not dispose of Multipaks intended exclusively to be collected "door to door".

g) **RUBBLE AND INERT WASTE:** materials left over from small building jobs, concrete and terracotta vases, plates, cups and other pottery tableware, terracotta and porcelain ware, stones and rocks, washbasins and other ceramic sanitary ware.

Small amounts of debris are permitted related to small-scale building works carried out directly by the users in their own homes and quantifiable in 0.5 cubic meters twice per year.

The following are not allowed: objects made from asbestos cement (Eternit), plasterboard, fibreglass, bituminous coatings.

h) **GARDEN WASTE:** branches, grass cuttings, leaves, vegetable garden and ornamental plants.

Do not dispose of stones and rocks, tree stumps and trunks and rotten fruit and vegetables; these last should be disposed of with other organic waste collected "door to door".

i) **BULKY WASTE MATERIALS:** mattresses, armchairs, sofas, carpets, linoleum etc. Collection refers to all non-recyclable material and not referred to other separated waste collections currently in force at the Recycling Depot.

j) **EEW – R1 - FRIDGES, FREEZERS, AIR CONDITIONERS**

k) **EEW – R2 – WASHING MACHINES, DRYERS, WASHER/DRYERS, DISHWASHERS, MICROWAVE OVENS, COOKING TOPS, ELECTRIC OVENS, GAS OVENS**

l) **EEW – R3 – TELEVISIONS AND MONITORS**

m) **EEW – R4 – SMALL CONSUMER ELECTRIC AND ELECTRONIC APPLIANCES:** vacuum cleaners, sewing machines, irons, deep fryers, blenders, computers (CPUs, mouse and keyboard), printers, fax machines, mobile and fixed telephones, video-recorders, radios, stereos, electrical tools, electric and electronic games etc.

n) **EEW – R5 – LIGHT SOURCES** neon and other gas or vapour bulbs, energy saving bulbs

o) **R.U.P. - DEAD BATTERIES:** disposable, rechargeable, disc and lead-free batteries.

p) **R.U.P. - LEAD BATTERIES:** car, motorcycle, anti theft batteries etc.

q) **R.U.P. - MINERAL OILS:** Mineral and synthetic oils used for the lubrication of engines and other mechanical parts of cars, motorcycles and other machinery.

r) **R.U.P. - PAINTS AND OTHER DOMESTIC CHEMICAL PRODUCTS:** paints, mastics, sealants, tempers, water-based paints, acids, thinners, inks, weed killers, anti-parasite agents, stain removers etc. including their containers on which the type of product within should be written in order to guarantee correct disposal. The containers should be closed correctly in order to avoid any leakage of the contents. Aerosol sprays are not included.

s) **R.U.P. - AEROSOL SPRAYS LABELLED "T" or "F":** full and empty pressurized chemical spray cans with Toxic or Inflammable symbols on the labels.

t) **R.U.P. - TONER CARTRIDGES:** for laser and ink-jets printers.

u) **R.U.P. - MEDICINES THAT ARE UNUSED OR PAST THEIR SELL-BY DATE:** dispose of the medicine in its own container (bottle/vial, tube or blister)

v) **R.U.P. - VEGETABLE AND ANIMAL FATS AND OILS:** resulting from food cooking and storage.

MEANS OF ACCESS FOR NON-DOMESTIC USERS

Non-domestic users with registered premises within the municipality can use the recycling depot solely for the disposal of waste similar to urban waste produced in the municipality or for the disposal of EEW on a 1: 1 (one to one) and 1: 0 (one to zero) basis.

The disposal of waste similar to urban waste is subject to the signing of a special agreement with CEM Ambiente, enrolled with the National Register for Environmental Management in category 2a - transport of non-hazardous autonomously produced waste. In cases of disposal in excess of 30 kg per type of waste, the accompanying Waste Identification form is required.

The transfer of electrical and / or electronic equipment waste (EEW) is subject to the signing of a special agreement with CEM Ambiente, enrolled with the National Register for Environmental Management in category 3a. The form for Waste Identification has been replaced by the compilation of Attachment II- Simplified Transport Document for electrical and electronic waste equipment.
